

CONSTITUTION OF SCBOA DISTRICT 11

ARTICLE I—Name

This organization shall be known as District 11 of the South Carolina Basketball Officials Association (SCBOA).

ARTICLE II—Territory

The area served by District 11 is as follows:
Horry, Georgetown, Williamsburg Counties and where requested

ARTICLE III—Purpose

The purpose of this association shall be:

1. To endorse and further the purpose of the South Carolina Basketball Officials Association's constitution and bylaws.
2. To promote uniformity in interpreting and enforcing the National Federation basketball rules and regulations and/or state adoptions to these rules.
3. To provide training and guidance for any official that has a need.
4. To provide a booking service to the schools in District 11 for junior varsity and "B Team" games.
5. To promote basketball as a game for the development of character, sportsmanship, citizenship and fair play.
6. At the discretion of the District Director, a sportsmanship award may be presented to an area middle and high school (junior varsity). The criteria for this award shall include, but not be limited to the following:
 - a) General sportsmanship of the team, coaching staff and fans
 - b) Treatment of the officials upon arriving at the game site
 - c) Dressing facilities, i.e. privacy, showers, etc.
 - d) Security and treatment of the officials at halftimes and the end of the game

ARTICLE IV—District Director and Review Board

A) Director

1. The District Director shall be elected by the District officials
2. The District Director shall serve a three year term and the Director may succeed him/herself if elected by the body of officials.
3. The District Director shall serve of the Board of Directors according to the SCBOA Constitution, Articles V and VI.
4. Duties of the District Director shall include, but are not limited to the following:

- a. Establish a liaison with area schools regarding scheduling, assignment of officials to scrimmages, sub-varsity games, area tournaments and establish reasonable game fees for said tournaments.
- b. Appoint a treasurer to collect and distribute district funds. The treasurer must be approved by the Review Board and is then a member of said Board.
- c. Assign observers to evaluate performance of district officials
- d. Assign, with the approval of the Association, two members of the Association to conduct an annual audit of the District's funds.
- e. Prepare a roster of all officials in District 11.
- f. Prepare a roster of all schools serviced by District 11.
- g. Prepare reply sheets for schedules and in-season meetings.
- h. Schedule junior varsity, "B Team" games, scrimmages, jamborees and tournament games of teams in District 11.
- i. Handle cancellations and reschedule games as necessary.
- j. Furnish forms for district applications, state and local date mark-offs, physical exams and a District 11 meeting schedule.
- k. Collect local association dues and booking fees from schools we service. Turn over all monies collected to district treasurer.
- l. Chair district out-of-season and in-season meetings and other functions of the general membership and the Board of Directors.
- m. Review performance and/or conduct of local officials and convene a Board of Directors meeting to discuss disciplinary actions, if warranted.
- n. Select official to represent District 11 in the South Carolina/North Carolina All-Star Game (eligible every four years). The official to represent District 11 is the official with the highest overall rating over the past five (5) years that has not previously officiated the game. It is the responsibility of the official to

notify the Director of his/her desire to officiate and provide the Director with past rating sheets.

- o. All expenses incurred by the Director (i.e. District associated telephone, mailings, educational and required trips to State Board meetings) will be paid by District 11. The Director is also to receive a salary equal to \$1.00 per game scheduled by the District Director.

B) Review Board

1. The Review Board is to assist the Director in recruiting, training and resolution of difficulties. The composition of the Board shall be as follows:
 - a) One member from each county of District 11, nominated and elected by members of District 11 from said counties.
 - b) Two members selected by the District Director from anywhere within the District
 - c) One treasurer selected by the District Director and approved by the elected Review Board members.
 - d) The immediate Past District Director.
 - e) One secretary selected by the District Director and approved by the elected Review Board Members.
2. The duties of the Review Board shall be as described in the SCBOA Bylaws, Article XVII and are as follows:
 - a) Each year the location review board and the district director shall review the records of all officials in the district with one or two year's experience in the Association in accordance with Article VII [Membership].
 - b) The local review board shall review the records of any new applicant in the district, who has acceptable experience in other states, or who was a former member of the South Carolina Basketball Officials Association but who does not have a rating. An appropriate rating for booking purposes shall be assigned to such official by this board.
 - c) The local review board shall also review the records of any member with two or more years experience that may be referred to the board by the district director or the Commissioner of officials. The board may adjust the rating of such official either upward or downward

or may recommend that the official be dropped from the Association.

ARTICLE V—Amendments to the Constitution

Amendments to the District 11 Constitution may be made by approval of three-fourths of those present at a meeting called for that purpose.

ARTICLE VI—Rules of Conduct

- A) Accepting Games: No member shall accept any in-state high school or middle school engagement unless the SCHSL or District 11's booking secretary assigns him/her. The district director may make assignments to non-member schools, Junior Varsity, B-team and middle schools regular season games.
